- » The one-time use of the Regatta (more than 10 vessels) the price is reduced by 20% if they stay more than 2 days.
- » 15 % off daily rate after 2 consecutive days.
- » 30 % off daily rate after 20 consecutive days.
- » Use of the berth for less than 3 hours is charged with 60% of the daily berth fee.
- » Charter daily berth rental fee is 50% higher.
- » On presentation of your valid B-MAX gas station voucher (minimum 80 L of fuel) you will be granted a discount of 10% on your daily berth place for one boat.
- » On Fridays, the price of the daily berth for vessels up to 13.99 m is increased by € 50.00, while for vessels of 14 m and above as well as for catamarans, the daily berth price is increased by € 100.00.
- » Upon presenting a receipt from Restaurant Yachtclub in the minimum amount of €100.00, the daily berth fee will be reduced by € 50.00
